- We presently have the 2019 Mitigation plan in final draft format. It is available for public comment until tomorrow. This was a complete rewrite of the plan.

Greg Smith

- Greg gave the attached Hazmat Report. Notable Items as follows.
 - In addition to the incidents, they also supported the polar plunge in Lafayette.
 - There is a free hazmat refresher March 11th-15th. Unfortunately, some team members cannot attend due to it being on weekdays.
 - The hazmat team has 2 new members from Medina FD
 - There is an MOU in progress with Lorain County hazmat and the drug task force has hazmat technicians, so they may be able to assist with personnel.

Once Around

Matt Sturgeon

- Now that the mitigation plan is done, the next project is the EOP, which is a higher-level plan. It is the overall strategy for dealing with incidents county wide.
- We now have access to GIS files for the storm sewers in Brunswick City and are working on getting files for the rest of the county.

Greg Smith

- It makes sense for us to mesh together the MCI & Mass Fatality plan, there is limited morgue space at the hospital. The largest majority of patients still self-rescue opposed to waiting for EMS.
- Medina Hospital is going back to Everbridge for mass notification due to the desktop alerting capability.
