The Medina County LEPC Meeting was called to order at 8:30am.

A motion to approve the March 1, 2012 meeting minutes was made by Mike Kollert, seconded by Mark Albrecht, and unanimously approved by all.

The FY 2012 Functional LEPC Exercise was held on April 19th with good reviews and no major issues. On April 25th the Ohio EMA recommended the SERC concur with the conduct of the exercise completing our requirements for the third year of the exercise cycle.

Jim Bigam brought up a few topics for review beginning with the fracking issue. Commissioner Friedrich noted that the Indoe Farm fracturing process is set to occur in the middle of May 2012. Second, Jim would like to remind everyone that the narrow banding change deadline is rapidly approaching.

Jeff Harraman has set up a training date for the Tier II grant which includes Medina County's assisted living facilities, dialysis centers, and retirement homes. The topic will be severe weather with presenters from the National Weather Service and Wood County EMA, and it will be at the EMA EOC on June 7th from 8:30am to 1:00pm. All participants will receive a new weather radio.

Ohio Edison and Ron Pfaff Electric will be donating equipment and labor to upgrade the electric service at the existing Montville Twp Service Garage for the purpose of housing the County's HazMat equipment to include trucks and trailers. The EMA will enter into an agreement with Montville for reimbursement of expenses as well as the storage of equipment. This should be complete by early next year.

The concern with the railroad tracks north of Columbia Rd was addressed by the Railroad Safety Task Force, and it will be handled by the railroad company.

The County will be moving forward with Everbridge and the Emergency Notification System as the final documentation was mailed on May 1st. Training has been established and will be available in class or on the web.
