- Grants Status
 - Director Nau briefed the current grant status:
 - The Emergency Management Performance Grant's performance period, which primarily pays our payroll, has been shortened but does not necessarily impact us since we can use the funding we get within the timeframe. It is possible we can get some supplemental funding as well, but next year's amount will not change. The payment for the grant is on hold, however, due to litigation in some other state and federal courts.
 - The Hazardous Materials Emergency Planning (HMEP) grant's funding has been delayed, but was approved.
 - EMA has been awarded a \$10,000 Enbridge Hazmat Equipment grant to procure meters and booms.
